Introduction

Port Sunlight Village Trust (PSVT) developed this action plan to identify opportunities for and to address risks to the significance, condition and integrity of the heritage in the Port Sunlight Conservation Area, as covered in chapters 3, 4 and 6 of this report and further described in the appendices. The plan was informed by the results of a landscape conditions survey, the exterior conditions survey of the houses, a 2016 householder survey, the findings from a visitor survey completed in 2017, and issues raised by residents and stakeholders during PSVT's robust CMP consultation process.

Arranged by heritage aims and objectives, the plan includes a brief description of a proposal, identifies the party responsible for delivering the work, projects a timescale for completion and where relevant, references national or local policies.

The action plan was written to align with:

- the mission, vision and values articulated in PSVT's strategic plan (2019);
- PSVT's heritage policies (adopted July 2017);
- National Planning Policy Framework (NPPF, 2012);
- Planning (Listed Buildings and Conservation Areas) Act 1990, amended to 2017;
- Climate Change Act (2008);
- Equality Act (2010) and
- Wirral Borough Council's Unitary Development Plan (UDP), adopted February 2000. For a complete list of the UDP sections, see the last page of this chapter.

The bigger picture and the future

The CMP is part of a suite of core documents for PSVT. Examples include community engagement and communications strategy and with an estate management plan. The estate management plan outlines PSVT's approach to site management and includes policies and actions to maintain high standards in the followings areas: access, safety, maintenance, environmental impact, climate change, biodiversity, conservation, community involvement, marketing and communication.

Funding

PSVT is ambitious for the future of heritage in the village. PSVT's work will be funded by a combination of revenue, capital investments and fundraising initiatives. PSVT adopted its first fundraising strategy in June 2018.

External stakeholder actions will be dependent upon the budget and priorities for those entities. PSVT will lobby and support stakeholders to ensure the sustainable management of the heritage in the village.
